Specific ACPHS Practicums count toward the 400 hour internship requirement. See ACPHS or CRC Program Advisor for additional information.

Admissions Process

- Generally an undergraduate grade-point average of 3.0 is required to be considered for admission.
- CRC will accept the PCAT score in lieu of the GMAT (The MS has no standardized testing requirement). MBA students may want to take the GMAT regardless so they may be considered for scholarship. Scholarship is determined by combination of GPA and GMAT score. Students who have not taken the PCAT will be required to submit a GMAT score if their ACPHS GPA is less than 3.2 by the start of the third year at ACPHS.
- Application materials include (The application can be completed online)
 - Application Form
 - Application Fee of \$50
 - Essay
 - PCAT or GMAT score (minimum of 500 on the GMAT).
Students who have not taken the PCAT and have a 3.2 or above from ACPHS at the start of the third year may waive the GMAT requirement. The MS has no standardized testing requirement.
 - Two Recommendations
 - Resume
 - Official Transcript(s)
- The MCAT and GRE are also accepted.

Additional Information

Students will be full-time ACPHS students through the end of their sixth year. Tuition for one class taken at Clarkson University CRC will be covered by a scholarship. Tuition for additional courses will be determined by Clarkson University

CRC and is payable directly to Clarkson University CRC. Tuition for Clarkson University CRC classes may be included in student loan requests if the course counts as an elective at ACPHS.
