## The Clarkson Reh MBA 4+1 Partnership Program

### Program Overview

The One-Year MBA is an accelerated, cohort-based program that can be completed in one academic year (nine months) at Clarkson's Potsdam, NY campus. The One-Year MBA program provides you with the opportunity to work in a team-oriented learning environment with world-renowned professors who teach a curriculum that is aligned with industry demand. Opportunities abound for specialized areas of study and international business experience. As a Clarkson MBA student, you will receive a differentiated graduate degree experience designed to prepare you to ignite your career immediately upon graduation.

### Academic Preparation: Business Foundations

The 4+1 partnership program means that we have identified undergraduate business courses at your institution that satisfy our foundations, which is typically the first year of a two-year MBA program. You should endeavor to complete the foundation courses as part of your undergraduate programs if possible (see Partner School Course Equivalents\*). Any or all of these requirements can also be completed, at no tuition cost to you, during our Summer Business Concepts Program (should you not have room for all coursework). This ensures that students of any major are welcome to apply.

### Specialized Funding

This articulation agreement with your institution also provides you with opportunities for **exclusive scholarship opportunities**. Upon admission and enrollment to Clarkson's MBA program, you will become eligible to receive:

- Fellowship Award of at least a 15% tuition discount.\*\*
- \$4,000 Travel Scholarship (applied only to international business experience).
- \$3,000 Graduate Assistantship.
- \$3,000 - \$9,000 Commit to Reh Early Decision Award for candidates who submit their intent to matriculate by March 1 of the year prior to enrollment.

Students who attend from a 4+1 partner institution and commit early are guaranteed at least a **25% tuition award**.

### Guaranteed Admission and Accelerated Decisions

Visit with a member of our team to learn about how you can **guarantee your admission** into our program as a graduate of one of our 4+1 partner institutions. We also offer **automatic admission** with a GMAT of 550 or higher and a 3.0 GPA.

*\*The enclosed list shows the equivalent courses at your institution that fulfill the prerequisites to complete the One-Year MBA program at Clarkson. Please note that a grade of 'C' or higher is required for prerequisite courses in order to be considered for entry into the program.*
